**MINIMUM ELIGIBILITY CRITERIA**

1. Tender Fee (Non-refundable) of Rs.590.00 (Incl. GST) and EMD of Rs.5,000.00 as per the tender conditions shall be paid separately, through RTGS/NEFT transfer. MSE/Startup/SSI Units interested in availing exemption from payment of Tender Fee & EMD should submit a valid copy of their **MSE UDYAM /Udyog Aadhaar registration certificate/Startup** and also have to submit the **Bid Security Declaration Annexure I**
2. The Bidder should have a minimum average Turnover of 5 Lakhs in the last three years ( 2022-23 , 2023-24 & 2024-25).
3. The Bidder should have minimum 5 year experience in scrap buying / selling business.
4. The Bidder should have GST registration and copy may submit along with PAN.
5. The bidder should have a valid license issued by Pollution Control Board (PCB) of the respective state for taking the PVC Scrap and the documentary evidence shall be submitted.
6. The Successful tenderer should provide Security Deposit (SD) by DD / Bank Guarantee from Nationalized/Scheduled Bank before commencement of the work, if the work is awarded. Security Deposit will be 3 % of the order value to a maximum of Rs.10,000/-.
7. A DECLARATION (as given in SCHEDULE-A) from the tenderer that the offer being submitted is as per the requirements given in this Bid is to be attached along with the Technical Bid.

**TERMS & CONDITIONS**

- 1) Rate offered should be the basic rate. The rates should be quoted based on the quantity in **price Bid Annexure 'II'** attached. Taxes are payable by the bidder as applicable at the time of taking delivery. If the concessional rate of Tax is to be levied by GAPL necessary Forms are to be submitted in advance. TCS as applicable, need to be paid at the time of delivery.
- 2) The Value of the scrap along with applicable rate of Tax/Duty must be paid in advance by way of DD/RTGS/NEFT drawn in favour of Goa Antibiotics & Pharmaceuticals Ltd, Tuem Pernem Goa.
- 3) It is the responsibility of the buyer to inspect the material. The company will not entertain any complaints on the quality, quantity, etc. after the materials were taken delivery by the buyer.
- 4) Period of contract will be for **“ONE YEAR** from the date of issuance of the Work Order.
- 5) The quantity mentioned herein are approximate annual requirement with staggered delivery and in case less or more quantity is required the suppliers should be prepared to effect supply at short notice on the same terms and conditions.
- 6) Technical & Price Bids should be in separate sealed covers. Technical and Price Bids shall be super scribed as **“Technical Bid”** and **“Price Bid”** on the respective covers in order to clearly identify between the two Bids. These two bids should be submitted in a **single sealed cover** with the respective Tender No. mentioned thereon. Technical Bid should be accompanied by Tender Fee & Earnest Money Deposit (EMD) DD / details of remittance. MSEs should submit the UDYAM for availing Exemption and also furnish the bid security declaration.
- 7) **The Price Bid of those Tenderers who qualify the Minimum Eligibility Criteria only will be opened. The date and time of opening of price bid will be intimated separately. The Price Bids of Tenderers who do not qualify will be returned unopened.**

- 8) Any accident or loss of life while loading the materials would be solely the responsibility of the bidder/contractor. GAPL will not entertain any claim in this regard.
- 9) The Contractor/bidder should arrange to remove the material **within 7 days** from the date of intimation from Logistic Department/Security gate.
- 10) It must be clearly understood that the Sale order will be issued to H1 parties based on the rate quoted for each item.
- 11) The vehicle for loading the materials should report to our Logistics Department by 10.00 AM during company working days. Loading & removing the scraps from GAPL premises after weighing/ measuring will be responsibility of the party. The materials once sold would not be taken back at any cost.
- 12) The contractor/bidder should ensure that no damage or loss is caused to the company property while clearing the scrap materials and the contractor is liable to make good such damage/loss immediately, if any, as per the decision of GAPL. The contractor/bidder shall ensure that the persons engaged by them for handling the scrap materials at the factory are not indulging in any malpractice, pilferage, etc.
- 13) All disputes or differences whatsoever arising between the contractor/bidder and GAPL shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian council of Arbitration and the awards made in pursuance there of shall be binding on both parties. All arbitration proceedings shall come under Goa Jurisdiction.
- 14) GAPL has the right to reject any Tender without assigning any reason.
- 15) The bidders/contractors are required to sign on all pages of the tender document. The incomplete tenders, without copy of ID & Address Proof and proper signature will be rejected. **PAN & GST is Mandatory.**
